Pre-Requisites:

- One open yard with proper boundary wall/ fencing.
- The open yard should be made of hard standing materials to facilitate plying of hydra, trailers etc. and storage of steel pipes etc.
- Covered Yard should be suitable for movement of Forklift & hydra crane.
- Covered yard Should be easily accessible for long body trailer movement
- Availability of Security Gate & Hut.
- Facility of Electricity and water. Charges will be paid by corporation.
- Land should be free hold and free from all encumbrances with clear title deed.
- Yard facility should be preferably on NH/SH or within 15 km from City center(Bus stand) Sikar(Raj)**

Separate Bids should be submitted for Open storage yard and covered storage yard. Interested parties are required to apply with the following details in two bid system as mentioned below:

Technical Bid (Part-I): To be submitted in separate envelope consisting of following documents **other than the cost** offered for the land:

- Relevant documents towards possessing the facility of yard & warehouse.

Price Bid (Part-II): To be submitted in separate envelope consisting of:

- Cost of offered land (Cost per Square meter as well as Total cost)
